

BYLAW NO. 285-20

A Bylaw of the Village of Avonlea to fix the rates to be charged for Sewer and Water.

The Council of the Village of Avonlea, in the province of Saskatchewan, enacts as follows:


1. All persons desiring to be supplied with water from the Municipality's water supply system shall make application to the officials of the Municipality. Each application shall be accompanied by the payment of a fee or **meter deposit** in the sum of **\$150.00** for Village Residents and as per the Water Supply Agreement for Rural Residence, (Schedule "D")
2. The Municipality may by bylaw ration or limit the amount of water furnished to any/or all consumers should circumstances deem to warrant such action.
3. If the water supply is shut off from the premises of a user for infringement of the provisions of this bylaw, same shall not be turned on until all penalties, fees, rates, charges, and arrears, if any, have been paid.
4. Water meters shall be read the first week of every quarter (January, April, July, October)
5. The charges to be paid by the water consumer whose water service has been turned on and for persons who own or occupy premises drained or that are by bylaw to be drained into the sewer shall be those set out in Schedule "A.1" attached, for those rural consumers whose water service has been turned on shall be those set out in Schedule "A.2", or as amended from time to time.
6. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached, or as amended from time to time.
7. Accounts for water service and/or sewer service shall cover a period of three (3) successive months, and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the said period of thirty days, the water service may be cut off. When the water service is so cut off, it shall not be resumed until all arrears have been paid, together with a fee of \$50.00 to cover the expenses of turning off the water and turning it on again; provided that if the Village is required to turn on the said water service outside the Village employee's regular working hours, the fee shall be \$150.00.
8. A penalty of 3 % will be added to all water and sewer accounts outstanding at the date of the next billing.
9. Bylaw No. 265-17 is hereby repealed.

THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.




